BECAUSE THE PANDEMIC CURTAILED IN-SCHOOL ACTIVITY ETA FOCUSED ON PROFESSIONAL DEVELOPMENT AND PEER LEARNING OPPORTUNITIES FOR ARTS TEACHERS THROUGH BI-COASTAL VIRTUAL GATHERINGS AS WELL AS SOME EQUIPMENT AND SUPPLY PURCHASES TOWARD THEIR ARTS GOALS.
